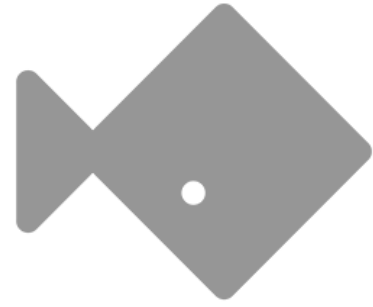


GRAYFISH DESIGN - TERMS OF SERVICE

This website is operated by Grayfish Design. Throughout the site, the terms “we”, “us” and “our” refer to Grayfish Design. Grayfish Design offers the website '<http://www.gray.fish>', including all information, tools and services available from the website and other services outside the website to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

When ordering any other design, it will include at least 1 sketch if not stated otherwise. After the client chooses a sketch, there will be 2 digital revisions if not stated otherwise. If there is no design agreement

made between the client and Grayfish Design after the 2 revisions, another revision can be done with added cost.

After the agreed amount for a project is fully paid and the final files have been delivered to the client, all rights of the design are transferred to the client, or the company the client works for.

We reserve the right to display all designs that we create for you on our website and our marketing material.
